



## CONTEST RULES

### Family Camp Giveaway ("Contest")

from 5am EST on April 7 to 11:59pm EST on April 23, 2026 ("Contest Period")

#### 1. HOW TO ENTER

No purchase required. To enter, listeners must be caller 7 after the cue to call is played. The contestant must correctly identify 3 items from the given summer category in under 10 seconds to have their name entered in the draw. The cue to call will be played two times each weekday, in the hours of 7am and 8am from April 7-23.

#### 2. ELIGIBILITY

Contest is open to Ontario residents (unless prohibited by law) who are 18 years of age or older at the Contest opening date. Employees of LIFE 100.3, Directors, contest sponsors, their immediate families and/or persons living in the same household are not eligible to enter this Contest. Only one qualifier is eligible per household address, name, and/or family residing in same house.

#### 3. PROCEDURE FOR AWARDING PRIZES

On April 23, 2026, a random draw will be conducted by LIFE 100.3 from among all eligible entries received during the Contest Period. The first contestant selected shall be declared the winner, subject to meeting all the conditions described in these rules. The Winner will be announced on The Get-up & Go Show on April 24, 2026.

The winner will be contacted by phone or email within a week following the draw and should claim their prize as instructed by LIFE 100.3 by no later than five days after the date they are initially contacted. If a winner cannot be reached within five days following the first attempt to contact, declines the prize, or fails to return the required release form, the prize shall be forfeited and LIFE 100.3 has the right, at its sole discretion, to select another winner.

Guest attendees will receive a Blue Meal Plan, which entitles them to all three meals of the day in our Riverside Dining Hall.

Any additional guests will need to be paid for individually for any outstanding fees. Families with over 3 children do not pay additional fees for programming per child. Meal fees will be charged for 5+ children. The winner must book their week through Fair Havens based on remaining availability, and before June 12th. Booking MUST be done over the phone with a customer service team member at Fair Havens. Standard booking rules & regulations apply unless otherwise specified by Fair Havens. Standard cancellation policies apply unless otherwise specified by Fair Havens. Any additional costs for extra guests, travel, food, parking, upgrades or other costs above the value listed above will be the responsibility of the winner.
