General Info

Participants must register prior to placing a bid. A credit card is required to register. This is an Internet only Auction, there is no telephone bidding.

A reserve price, starting price, or minimum bid may be used at the discretion of Trust Communications Ministries (LIFE 100.3). See individual items for details.

Auto-bidding may be used. Defined: Auto-bidding places bids on your behalf at the lowest possible increments. Simply enter your maximum bid (the highest amount you are willing to pay). The goal of auto-bidding is for you to win the auction at the lowest possible price. Therefore, the current bid will equal the former bid plus the bid increment.

Bidding will close at the stated time on each item.
